

Objective

This type of portfolio is NOT a risk-free portfolio, rather, it is suitable for a client who is prepared to invest into equities at the right time and is focused on both the risk and return and looking to achieve a balance. The portfolio is managed dynamically by altering the asset allocation using assets that carry market risk and using all assets that are available from the investment universe. The asset allocation in this portfolio will vary between a benchmark of 0% equity and 55% equity to achieve the portfolio objectives, provided economic conditions permit. **The portfolio will be managed to try and limit the indicative capital loss in any 12-month period to 10% in a significant event and 6% in normal market conditions and to target an annualised total return averaged out over a full economic cycle (5 – 7-year period) of 6% before any adviser, custodian, switch and/or discretionary investment management fees, but after fund manager charges.**

Management

The benchmark we use for comparison purposes for volatility is **AFI Cautious** noting that this benchmark currently holds **48.13% in Equity** (Analytics, 1st May 2020) and is therefore more aggressive than this portfolio. The benchmark also has no capital preservation mandate. It would therefore be expected that this benchmark would outperform the model and that the volatility of the benchmark would be higher. The model performance therefore cannot be directly compared to the benchmark.

Our OBI Active 5 portfolio is a cautiously balanced portfolio with the delivery of outcome and capital preservation at its core which aims to achieve a return outcome of 6% per annum.

Market Outlook

At the beginning of March, as the global economy powered down in the midst of the coronavirus pandemic, the chances of a global recession became almost inevitable, as severe restrictions on businesses and households were imposed by governments desperately trying to contain the outbreak. Given this impending risk to the global economy and financial markets, the portfolio was placed into capital preservation mode on the 9th March as to protect capital the best we could amid the turmoil, helping to prevent further losses and limit extreme volatility throughout the month.

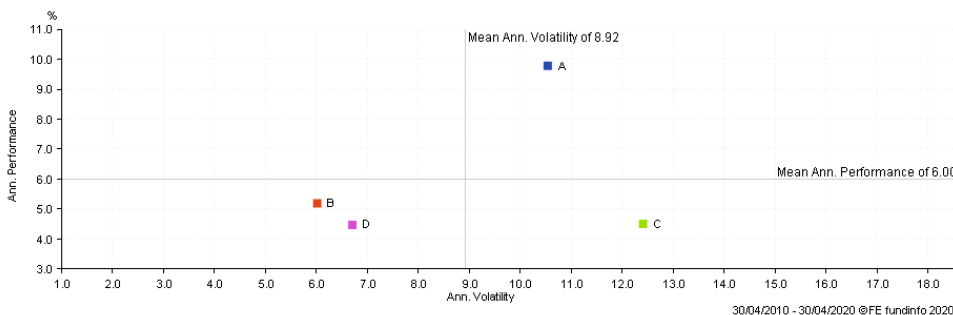
Economic data on a global scale continues to deteriorate as the impact of the coronavirus-induced lockdowns becomes clear, however markets now appear to be looking past the sharply deteriorating near term economic data to focus on expectations for a recovery. With governments across the globe now starting to look towards setting a timeline for a reopening of their economies, most economists are now expecting to see a recovery in activity over the second half of the year, followed by strong growth in 2021. Expectations are that economic growth in 2021 will be bolstered by low international interest rates alongside continued support from central banks and governments as the global economy returns to the new normal following the coronavirus pandemic. While there will undoubtedly be further volatility ahead from here, with the medical news flow beginning to improve as key economies look to restart their economies, our medium term has begun to brighten.

Portfolio Positioning

After re-entering markets with a defensive allocation earlier this month, following an in-depth analysis of the data and a continued improvement in our medium-term market outlook on risk assets, we recently implemented our return to investing more normally across the portfolios. In doing so, we have redeployed cash into equity and non-equity assets across the portfolios as part of the final stage of our re-entry strategy. In doing so, we have taken the opportunity to add exposure at attractive levels, while complementing our existing exposure and increasing the level of diversification within the portfolios, putting us in a strong position moving forward.

The portfolio has been constructed with a high level of diversification in terms of asset classes and geographies, with a mix of bond, equity, and property exposure to meet the portfolios objectives over the long term. The bond exposure is gained through high quality, actively managed strategic bond funds and the equity exposure within the portfolio is gained through exposure to diverse, globally managed funds as well as passive trackers, while the property exposure is gained through UK direct property funds.

Portfolio Volatility



This scatter chart reflects annualised volatility and return in GBP over the past 10 years. Over the long term, we would expect the OBI portfolio to exhibit a lower level of volatility than the benchmark.
