

# OBI Model Portfolio Active 6



## Objective

This portfolio is NOT a risk-free portfolio, rather, it is suitable for a client who is prepared to invest into equities at the right time and is focused on both the risk and return and looking to achieve a balance. The portfolio is managed dynamically by altering the asset allocation using assets that carry market risk and using all assets that are available from the investment universe. The asset allocation in this portfolio will vary between a benchmark of 0% equity and 65% equity to achieve the portfolio objectives, provided economic conditions permit. **The portfolio will be managed to try and limit the indicative capital loss in any 12-month period to 12% in a significant event and 7% in normal market conditions and to target an annualised total return averaged out over a full economic cycle (5 – 7-year period) of 7% before any adviser, custodian, switch and/or discretionary investment management fees, but after fund manager charges.**

## Management

The benchmark we use for comparison purposes for volatility is **AFI Balanced** noting that this benchmark currently holds **69.36% in Equity** (Analytics, 1st June 2021) and is therefore more aggressive than this portfolio. The benchmark also has no capital preservation mandate. It would therefore be expected that this benchmark would outperform the model and that the volatility of the benchmark would be higher. The model performance therefore cannot be directly compared to the benchmark.

## Market Outlook

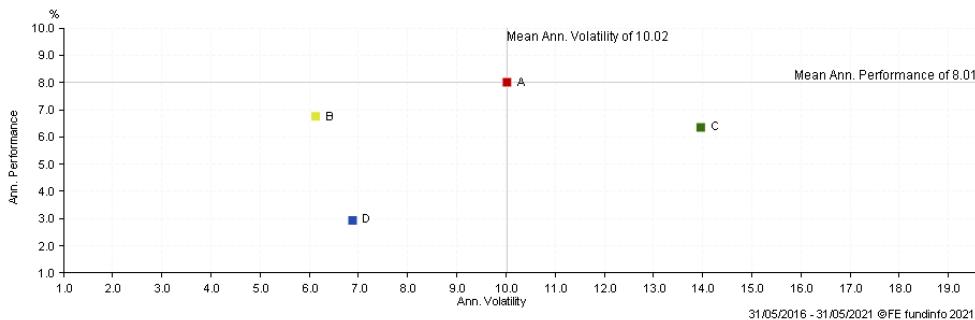
Having started the year on strong footing, the majority of global regions have seen their economic fundamentals continue to improve, as vaccination rates and policy stimulus help to drive upward revisions in economic data. The UK, US, and Europe are leading the global inoculation efforts, which has subsequently resulted in upward revisions to the UK and Europe's GDP forecasts for 2021. Although the improving outlook contributed to the acceleration in government bond yields in February and March, financial markets maintained their positive trajectory until the start of May, when inflation and policy expectations increasingly dominated news flows. As a result of this, those valuations that had shown signs of being expensive became increasingly volatile throughout May. After a choppy month in markets, this short-term uncertainty has begun to abate as investor sentiment returns, with concerns over runaway inflation easing while investors maintain their optimistic outlook for financial markets.

As long-term investors, we have viewed many of the market movements in 2021 as short-term noise, with no changes to our underlying assumptions on the global recovery and market outlook. Looking further ahead, although it is clear that volatility remains in the short-term as market participants focus on the recovery, inflation pressures, and future policy, we remain optimistic and continue to see opportunities arising as the outlook improves, with global growth remaining well supported by governments and central banks.

## Portfolio Positioning

Over the past month, we capitalised on over-extended valuations to take some profits on our holdings and plan to re distribute these into new opportunities that we believe have the potential to outperform over the coming months, as we transition through the global economic recovery. The portfolio has been constructed with a high level of diversification in terms of asset classes and geographies, with a mix of bond, equity, and property exposure to meet portfolio objectives over the long term. The exposure is gained through a high-quality mix of actively managed and passive, globally diverse equity and multi asset funds. The portfolio has recently benefitted from its diverse asset allocation, reducing recent market volatility when compared to the benchmark.

## Portfolio Volatility



This scatter chart reflects annualised volatility and return in GBP over the past 5 years. Over the long term, we would expect the OBI portfolio to exhibit a lower level of volatility than the benchmark.
